**The Superannuation (Teaching and Public Boards)
Interchange (Amendment) Rules 1971**

The Secretary of State for Education and Science, with the consent of the Minister for the Civil Service, in exercise of the powers conferred on her by sections 2 and 15 of the Superannuation (Miscellaneous Provisions) Act 1948(a), as amended by section 11 of the Superannuation (Miscellaneous Provisions) Act 1967(b) and as read with the Minister for the Civil Service Order 1968(c), hereby makes the following Rules:—

1. These Rules may be cited as the Superannuation (Teaching and Public Boards) Interchange (Amendment) Rules 1971 and shall come into operation on 1st February 1972.

2. The Interpretation Act 1889(d) shall apply for the interpretation of these Rules as it applies for the interpretation of an Act of Parliament.

3. Schedule 3 to the Superannuation (Teaching and Public Boards) Interchange Rules 1968(e), as amended(f), is hereby further amended by the addition thereto of the following bodies and dates:—

The Arts Council of Great Britain	1st January 1967
The British Airports Authority	1st April 1966
The British Productivity Council	1st April 1968
The British Steel Corporation	1st July 1969
The Church Commissioners	1st April 1948
The Meat and Livestock Commission	1st October 1968

4. In relation to a person becoming, or ceasing to be, employed by a body named in rule 3 the operative date for the purposes of the Superannuation (Teaching and Public Boards) Interchange Rules 1968 shall be the date of the coming into operation of these Rules.

EXPLANATORY NOTE

(This Note is not part of the Rules.)

These Rules extend to the Arts Council of Great Britain, the British Airports Authority, the British Productivity Council, the British Steel Corporation, the Church Commissioners and the Meat and Livestock Commission the existing arrangements for the preservation of superannuation rights on changes of employment between teaching and other public boards.

The Rules may have retrospective effect in certain cases under the express powers of, and subject to the safeguards required by, section 2(5) of the Superannuation (Miscellaneous Provisions) Act 1948.
