# ROAD TRAFFIC, WALES

The A470 Trunk Road (Talerddig to Commins Coch, Powys) (Temporary Prohibition of Vehicles) Order 2025

*Made* 4 June 2025

Coming into force 12 June 2025

The Welsh Ministers, as traffic authority for the A470 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

## Title and commencement

**1.** The title of this Order is the A470 Trunk Road (Talerddig to Commins Coch, Powys) (Temporary Prohibition of Vehicles) Order 2025 and this Order comes into force on 12 June 2025.

# Interpretation

# 2. In this Order—

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order:

"the trunk road" ("y gefnffordd") means the A470 Caersws to Machynlleth trunk road;

"works period" ("cyfnod y gwaith") means intermittent periods commencing at 19:00 hours on 12 June 2025 and ending when the temporary traffic signs for each period of works are permanently removed.

#### **Prohibitions**

- **3.** No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the lengths of the trunk road specified in Schedule 1 to this Order.
- **4.** No person may, during the works period, drive any vehicle of or over 14' 6" on the lengths of the trunk road specified in Schedules 1 and 2 to this Order.

### **Application**

**5.** The prohibitions in articles 3 and 4 apply only during such times and to such extent as indicated by traffic signs.

# **Duration of this Order**

**6.** The maximum duration of this Order is 18 months.

#### **SCHEDULE 1**

The length of the trunk road at Talerddig, Powys that extends from a point approximately 100 metres east of the centre-point of Pont Bell railway bridge to its junction with Bwlch yr Iaen estate at Dolfach, Powys.

The length of the trunk road at Llanbrynmair, Powys that extends from its junction with the centre-point of the county road outside the property called Llysun to the property called Newgate (west of Tripgate bridge).

The length of the trunk road at Commins Coch, Powys that extends from a point 476 metres east of the permanent 20 mph speed limit sign to the centre-point

of the lay-by located approximately 1.35 kilometres west of that permanent 20 mph speed limit sign.

# **SCHEDULE 2**

The length of the trunk road that extends from its junction with Bwlch yr Iaen, Dolfach to Pontdolgoch railway bridge.

The length of the trunk road that extends from the property called Newgate (west of Tripgate bridge), Llanbrynmair to Pontdolgoch railway bridge.

The length of the trunk road that extends from the centre-point of the lay-by located approximately 1.35 kilometres west of the permanent 20 mph speed limit sign at Commins Coch to Pontdolgoch railway bridge.
